\_\_\_\_\_ I recognize that having a quilt block as part of the Taylor County Barn Quilt Trail may increase traffic and/or visitors to its location.

\_\_\_\_\_ The quilt block is the property of the owner. I will allow my barn/structure to be photographed by the public. Taylor County Barn Quilt Committee will have promotional rights, i.e. postcards, photos, calendars to any quilt block on the Taylor County Quilt Trail.

\_\_\_\_\_ The quilt block must remain on the structure for at least 3 years in order to be included on the Barn Quilt Trail and I will be responsible for any repairs or upkeep needed.

\_\_\_\_\_ The Taylor County Barn Quilt Committee must be notified if the quilt block is removed, becomes too deteriorated, needs to be repaired or renewed so that it can be removed from the publicity materials.
